- Complete the fields below, sign and date the form.
 - Purchase the minimum of one bulk bag, which contains 200,000 coins,
 - Pay for the coins at face value plus a processing fee, which equal 3% of total order value (\$1,500 per bag)
 - Pay in full and in advance via electronic funds transfer to the United States Mint (instructions will be provided after the order is entered and the inventory is confirmed),
 - Assume all shipping costs and arrange pick up to receive coins at the dock of United States Mint facilities in Philadelphia or Denver for coins manufactured in Philadelphia or Denver, respectively
 - You will receive pick up instructions (for arranging carrier appointment, truck inspection, and driver clearance) and be contacted to coordinate a pick up appointment date/time,
 - The order will be released after all pre-arrangements are fulfilled (e.g., the electronic funds transfer has been received, the shipment is ready, and clearances confirmed).
